DOGS: Dogs must be under control at all times. This is a fully public venue so please keep barking to a minimum, pick up after your dogs promptly and note that your dog **MUST** be on leash when not crated or in the search areas. Any handler displaying inhumane or aggressive treatment to any dog, the public or other handlers (physically or verbally) will be asked to leave the premises without refund. All dogs must be on a flat collar or harness in the search area. Leashes must be cloth or leather of any length in the search area.

COMPETITORS: Through the submission of their entries, acknowledge that they know the Rules and Regulations. See Master Rule Book on the CSSDF web site www.canadiansportscntdetectionfederation.com to familiarize yourself with all rules.

DIRECTIONS: West from Toronto to Paris – Take Hwy 403 (Hamilton/Brantford - Go through Hamilton/Brantford -- Exit: Hwy #24 Paris/ Simcoe (Rest Acres Rd). turn to the right on ramp towards Paris, at set of lights (Hwy #2) turn left (Cemetery directly in front of you), follow until you see sign for Bishopsgate Rd. (turn left) (3rd house on left after you cross back over 403 -Perfect Scents K9 sign out front (#452 Bishopsgate Rd. Brantford On).

NOTE: Handler/Dog Teams may enter one or all components. All three (3) components (Container, Interior, Vehicle) must be successfully completed (qualifying scores earned) to earn the CSSDF – Component Ribbon – It is not necessary to complete all three on the same day, however, if you do - The honorary CH (Champion) will be added to the title of any dog who does complete all three components on the same day, at the same trial. If you pass your component and would like to move-up the next day – please let us know and we would gladly place you in the running order.
